Confirm that I will be attending the SSE Soccer Institute from February 2018 until the end of October 2018.

I undertake to effect payment of the sum of R300.00 (Three Hundred Rand) (South African players) for the Academy registration process and an additional amount of R80.00 per session. The monthly fee includes all practices and matches. Academy players must note that 50% of the cost must be paid to the Academy before the 1st of March 2018 and the remainder of the cost must be paid before the 1st of June 2018. All players must note that no refunds will be paid if the player decides not to attend the Academy, leaves at any stage for any



reason and or if the player is expelled or injured while in the Academy. A bill with the number of sessions attended will be given to the registered player at the end of every month. Registration fees are to be paid up front, as stipulated above.

All funds in the form of payment are still payable to the Academy if for any reason the player does not finish or start the Academy. Clinics will also be offered at an additional cost to be stipulated at the time. The clinics are not compulsory although they are recommended to further the individual's knowledge and growth of the game.

I undertake further to attend select practices, training sessions and lectures when stipulated accordingly to the programme, unless I am sick, injured or attending university lectures and confirm that I will excuse myself in advance. I shall further endeavour to perform at my best and to uphold the name of the SSE Soccer Institute at all times. If the player acts against the above-mentioned code he must understand that he will be punished in accordance with disciplinary code put in place at the beginning of the Academy year.

I hereby give my assurance that the skills and materials learned and used shall and will not be used in the future to open a soccer school or to act as competition to the SSE Soccer Institute.



INDEMNITY:

Whilst every precaution will be taken to ensure the safety of the participant, it must be clearly understood that neither the owners of the property (CBC), nor the SSE Soccer Institute organisers or coaches will be held responsible for any loss nor injury suffered by any of the Academy participants. Furthermore, SSE players are not allowed to use the facilities of CBC Mount Edmund, outside of the change rooms by the training fields, unless they are a pupil of the school. SSE players from outside of school are not permitted on the property outside of the given training/clinic/match times and must leave the school grounds at the end of every session.

The SSE Soccer Institute and CBC Mount Edmund shall also not be held responsible for any loss, injury, death, breaking of the law or sickness sustained or performed by any of the participants whilst staying in South Africa for the duration of the Academy.
